Overview

The system enables Resellers to access the *Catalog* module once Resellers successfully activated their account on the CloudBlue Connect platform. In case their hub and their marketplace are successfully created, Resellers will be able to enroll a syndication contract via the Catalog module.

Syndication (or *syndicated*) contracts are required for Resellers to start distributing selected products via their specified commerce systems. Therefore, the following tutorial showcases how to locate products that are available for reselling operations and how to enroll a syndication contract on the Connect platform.

Prerequisites


Before proceeding with the provided tutorial, make sure that the following requirements are met

- Your CloudBlue Connect account and your service contract are successfully activated.
- Your hub is registered, and your marketplace is created.

Reviewing Catalog

Navigate to the **Catalog** module to access products that are available for reseller operations. In case several Distributors provide products for your Connect account, the system allows selecting your business partner before accessing the catalog interface.

The provided catalog interface displays a list of products with their names, icons and descriptions. If your business partner provides multiple products of the same category, click **More** to browse through all products of your selected category. Furthermore, you can use the search bar at the top-right corner of the screen to quickly find a required product.





Click on your selected product to access the **Product Information** screen. Thus, the system allows accessing product overview, versions, video presentations, images, Vendor information and so on. Resellers can access the *Syndicated Contracts* tab to enroll your contract as demonstrated below.




Access the **Syndicated Contracts** tab from the **Product Information** screen. Thereafter, click the **Enroll** button to launch a syndication contract enroll wizard.

Follow the wizard steps to enroll your syndication contract:

- Introduction: This step introduces your selected product and the syndication distributor.
- **Marketplace**: Select your created marketplace that will be used to distribute your selected product.
- Agreement: Review the provided agreement and check the *I have read and accepted the agreement* checkbox to continue.
- Submit: Specify additional information if necessary. Click the Submit button to enroll your agreement.
- **Summary**: As a result, the system provides your syndication contract summary. Click the *Go to Details* button to access the contract details screen. Otherwise, click *Close* to close the summary.

Note that thy system also enables Resellers to enroll additional syndication contracts by clicking the **More** button next to the syndication agreement. Therefore, the system allows using several marketplaces for your selected product. In this scenario, Champions Corp enrolled one syndication contract.

Your Next Step

Once the Syndication Distributor approves this enrolled contract, Resellers will be able to examine the product data, offers and pricing details of this product. Furthermore, the system enables Resellers or their integrated commerce systems to generate subscriptions. Access the Subscription Management to proceed with the Reseller Tutorial.
