Product Listing Creation

Overview

The product listings processing is a part of the Product Flow on the CloudBlue Connect platform. Once Vendors finalized *product definition* operation, it is necessary to create a listing request to publish product on a required marketplace. In case Distributors accept a request, the defined product will be successfully listed. In case of an error, Distributors can also reject a request. Therefore, the system enables Vendors to manage listing request and update provided information.

Use the guidelines below to learn how Vendors can create a new listing request and successfully submit this request to Distributors.

Prerequisites

Before proceeding with the following tutorial, make sure that the following prerequisites are met:

- Vendor Portal is activated and the program contracts is signed.
- Distribution agreement and distribution contract are *Active*.
- Product definition operation is complete and public product version is saved.

Generating Product Listings

The following scenario showcases *Front Street Inc* that successfully defined the product on the Connect platform. This Vendor is required to create a listing request. Therefore, the specified product will be successfully published within the marketplace owned by *Mighty Mick's LLC*.

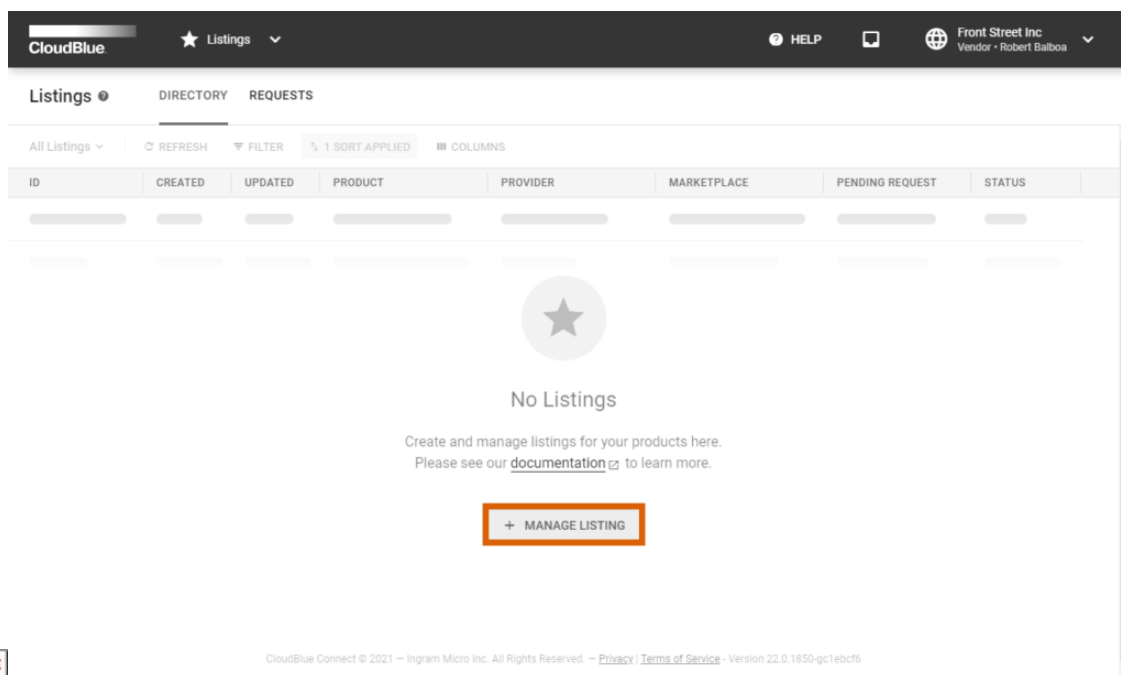


Connect Marketplace

In case you want to enlist your product to the Connect Marketplace, it is required to select the *Connect* distributor and *Direct* marketplace. For more information, please follow the instructions that are presented in the *Enrolling to Connect Marketplace* article.

Listing Wizard

Access the **Listing** module and click **Manage Listings** to launch a *manage listing* wizard.

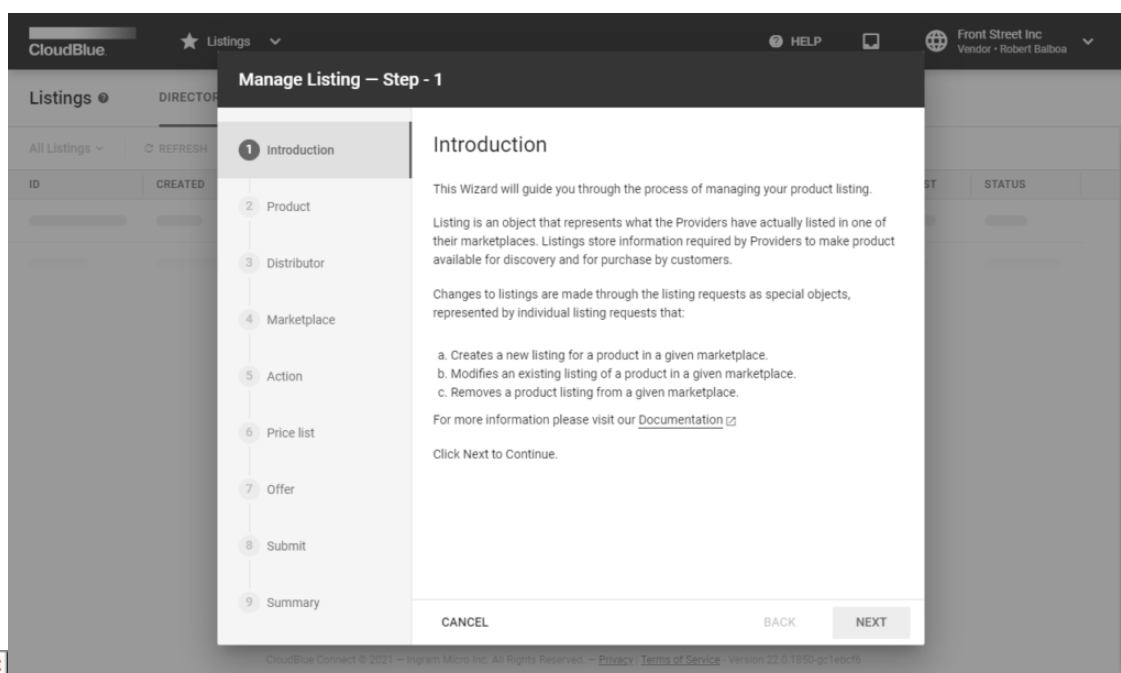


Note that the system provides a notification in case your *product version* is not saved or your distribution contract is not *Active*.

In case the system launches the wizard, follow the wizard steps to successfully create a listing request.

Introduction

The wizard will provide an introduction that explains the product listing concept.

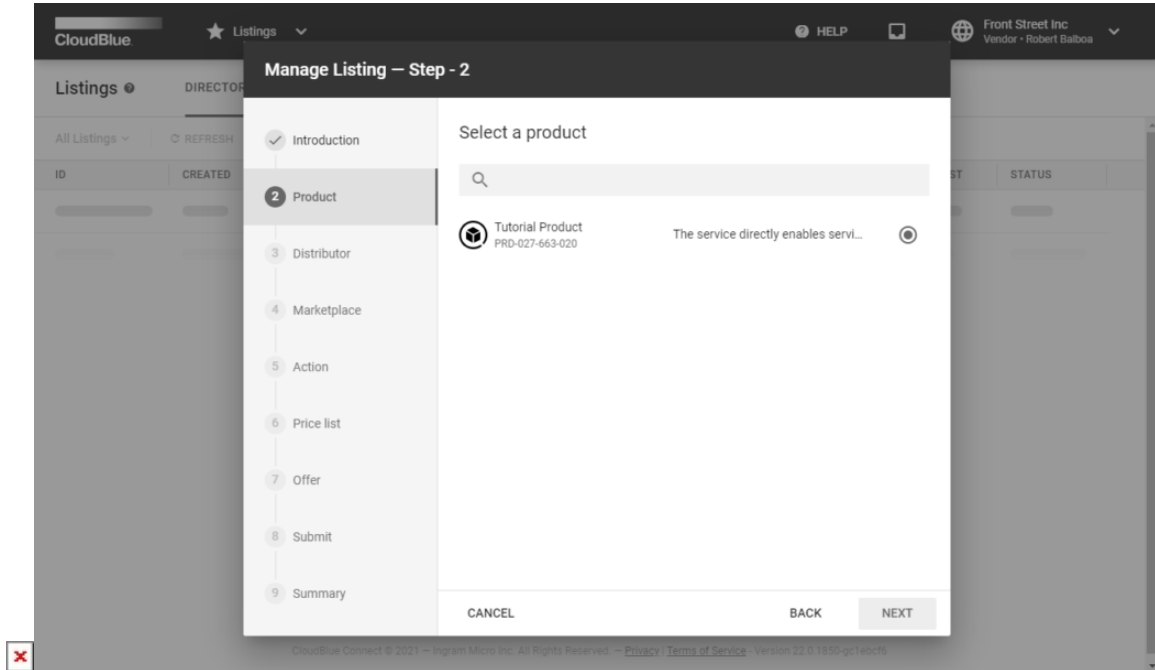


Review the concept and click **Next** to continue.



Select your product

Choose your product from the provided list.

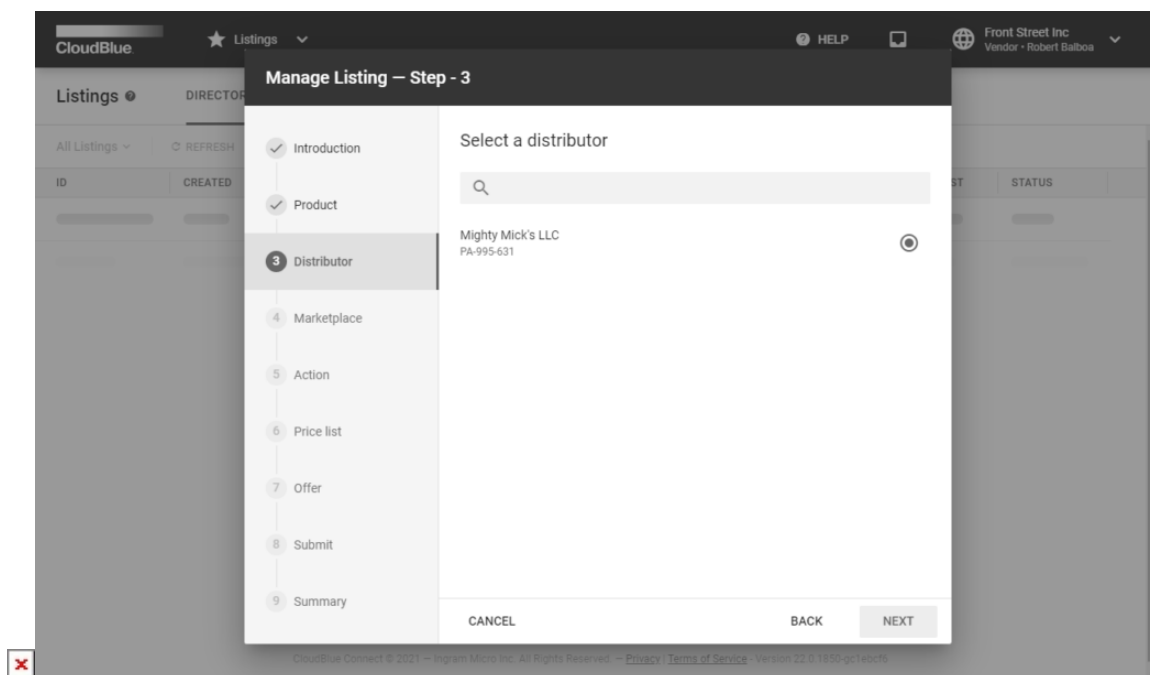


In this scenario, *Front Street Inc* selects their defined product.

Click **Next** to continue.

Select a distributor

Choose your distributor account in the following form:

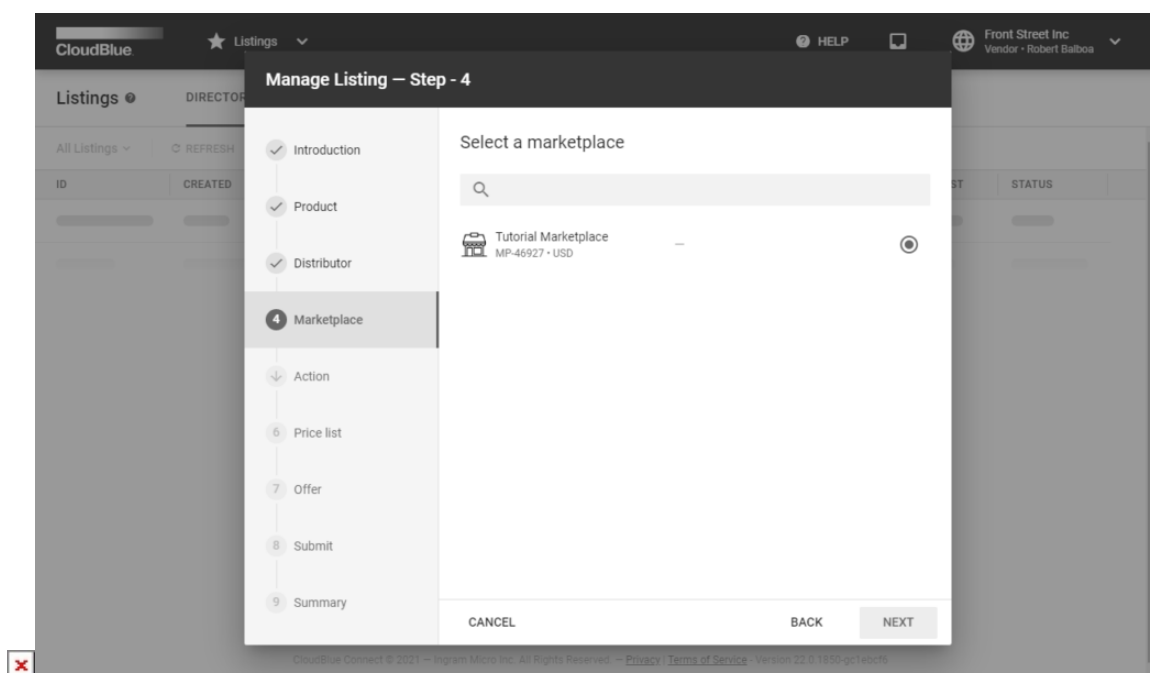


Front Street Inc collaborates with *Mighty Mick's LLC*. Therefore, this distribution company is selected.

Click **Next** to continue.

Choose a marketplace

Select a marketplace where you want to publish your product.



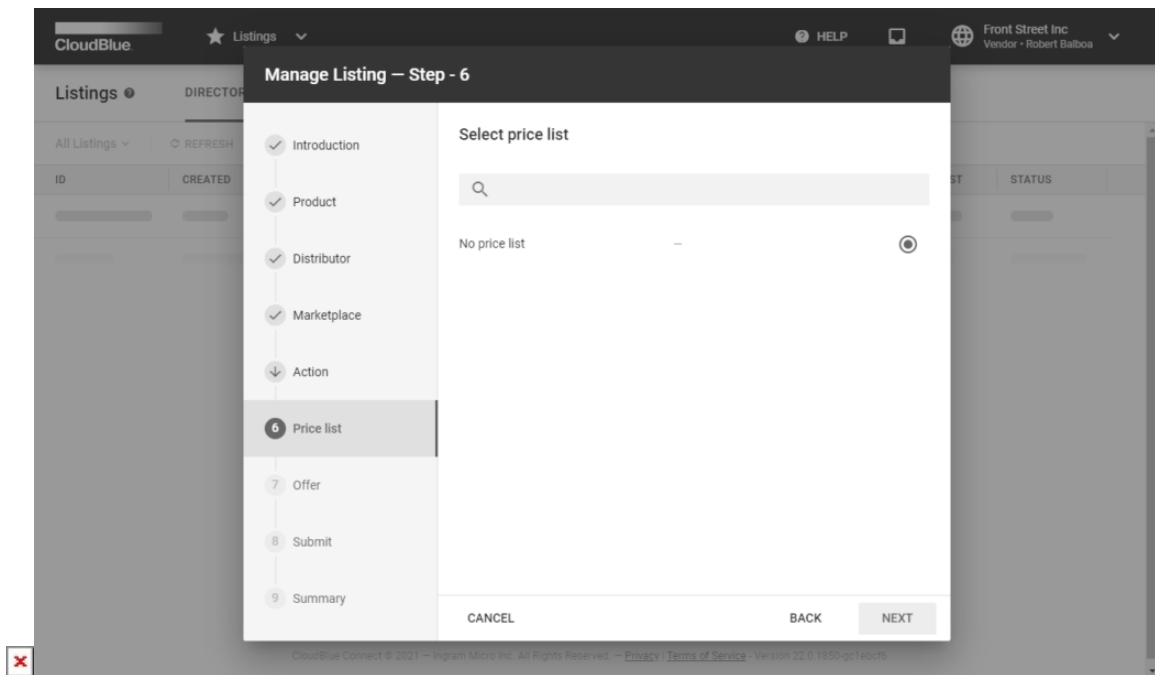
In this scenario, Front Street Inc selects a marketplace created by Mighty Mick's LLC



Click the **Next** button to continue.

Select a price list

Specify a price list in the following form:

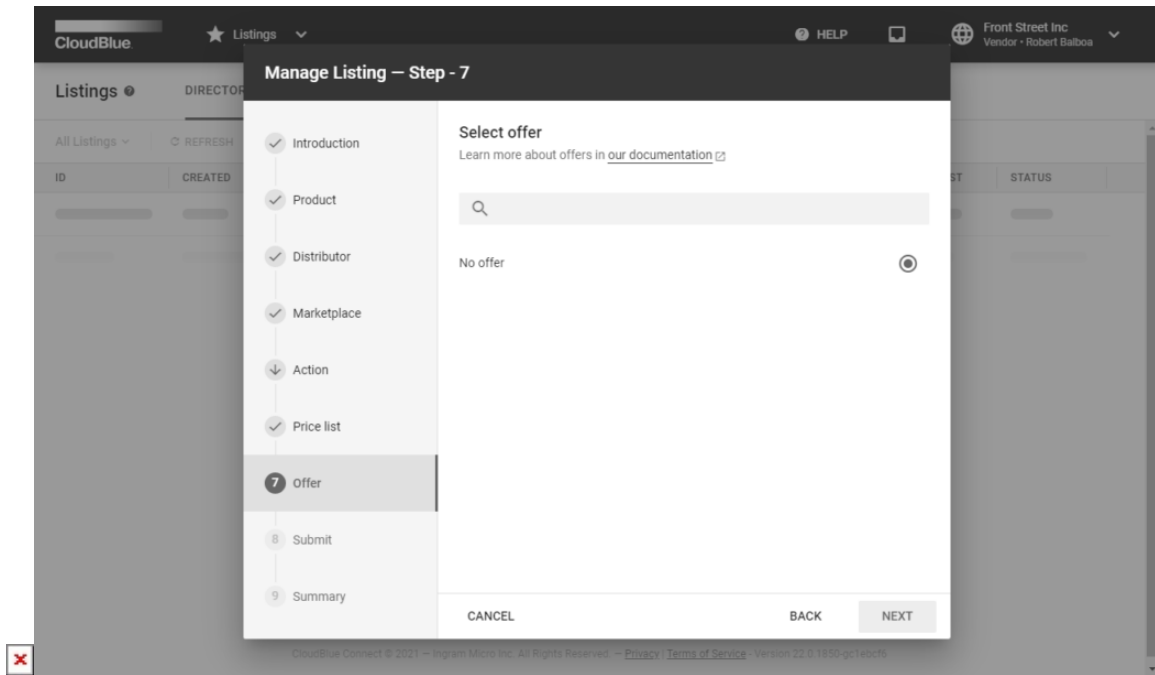


Front Street Inc decided not to specify any price lists. Therefore, the system prompts this Vendor to select the *no price list* option.

Click **Next** to continue.

Select your offer

Specify your offer in the following form

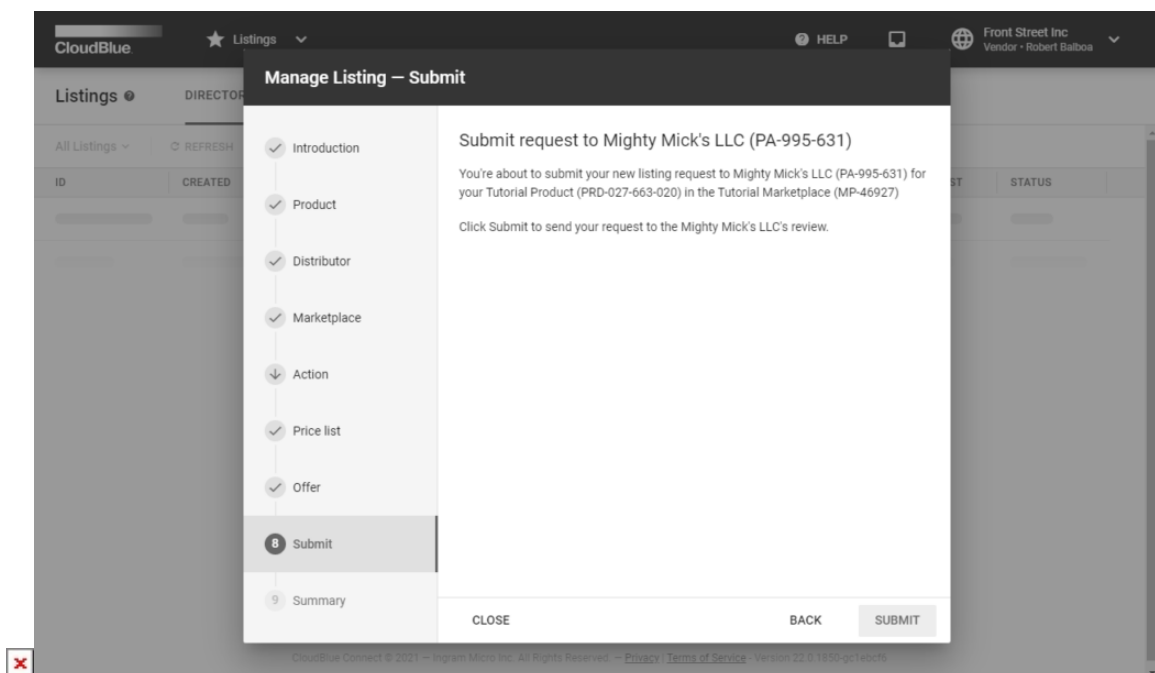


In this scenario, Front Street Inc decided not to provide offers yet.

Click the Next button to continue.

Submit your request

Make sure that selected marketplace and provider data are correct before submitting your request.

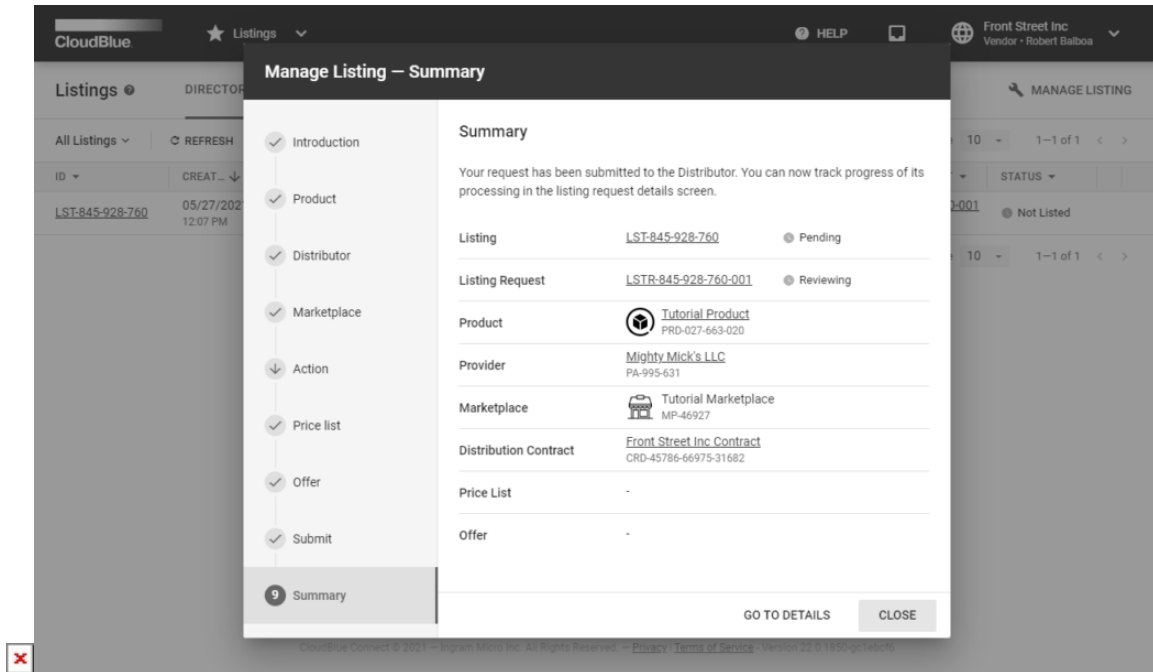


Thereafter, click the **Submit** button to finalize your listing request creation and submit the request.



Review your summary

As a result, the system your created listing summary.



Review your request by clicking the **Go to Details** button. Otherwise, click **Close** to close the summary.

Front Street Inc successfully created a listing request and submitted this request to the aforementioned Distributor *Mighty Mick's LLC*. Thus, this Distributor is required to process the request and deploy the product on the specified marketplace.

Your Next Step

Once Vendors submit a listing request with required products and this request is *marked as completed* by Distributors, the *Product Flow* will be successfully concluded. Therefore, Distributors or their system can generate subscriptions and their corresponding fulfillment requests that should be processed by Vendors.
