1.7.1 Mass Management of Product Items

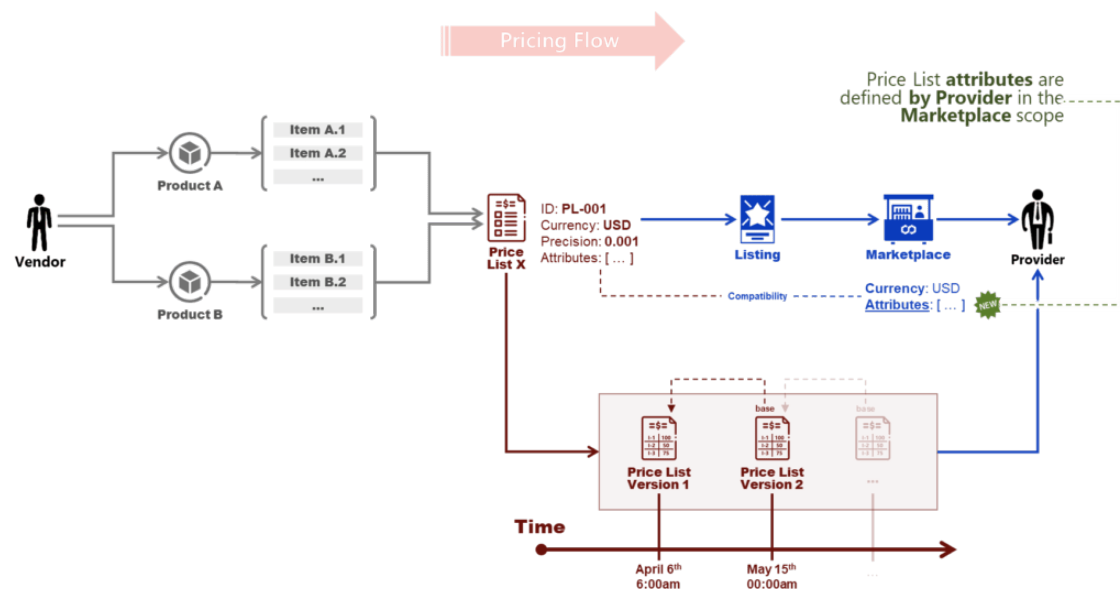

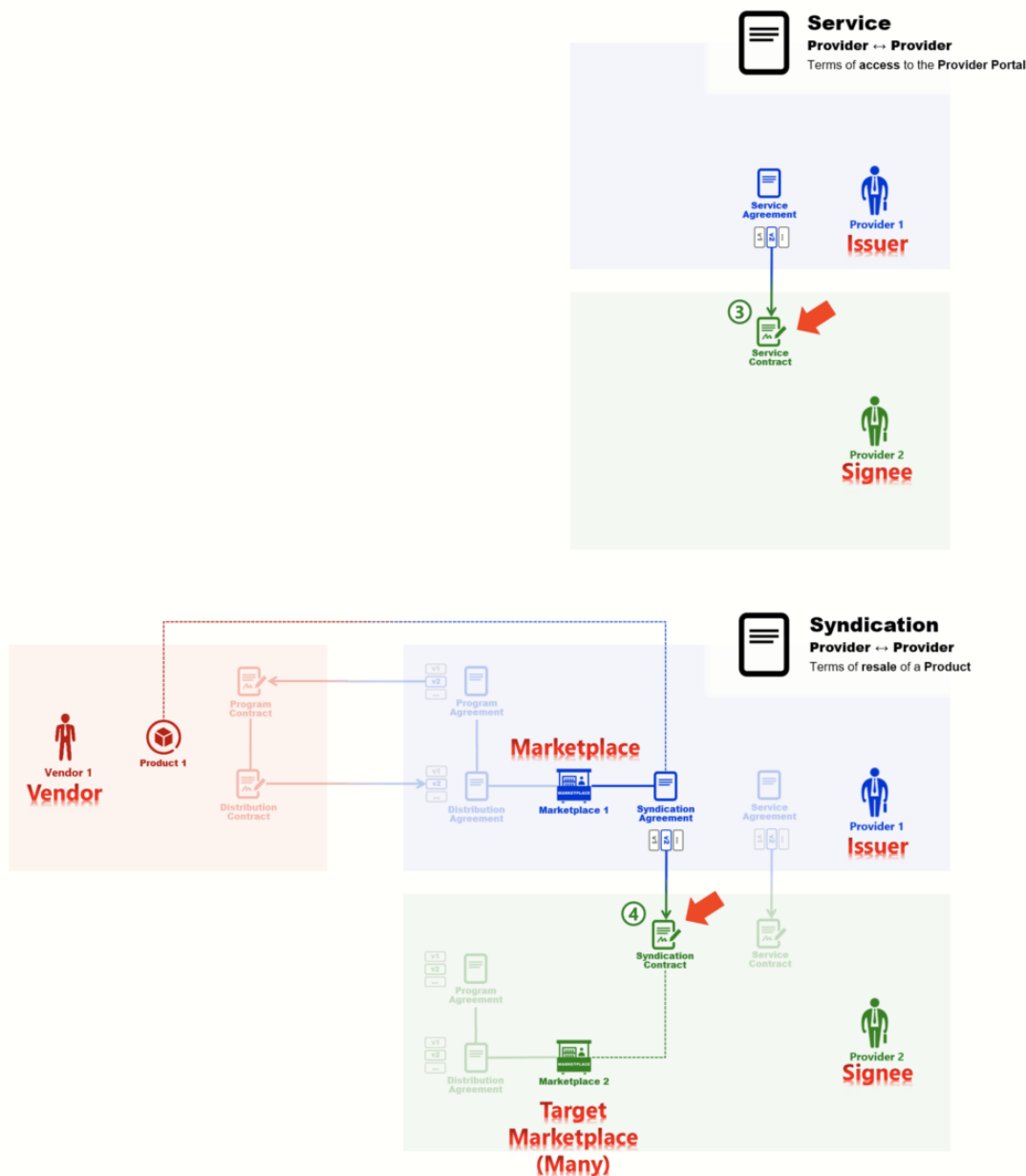
