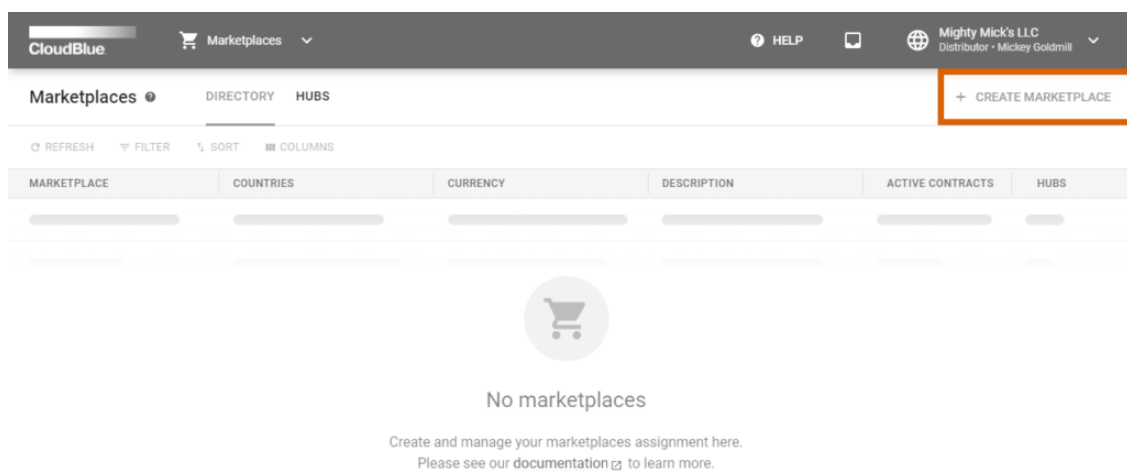


The following showcases how to successfully register a new marketplace and perform other operations with marketplaces on the CloudBlue Connect platform. It is also recommended to familiarize yourself with the Marketplace Overview first.

Marketplace Creation

Proceed to the **Marketplace** module to access a list of your marketplaces. In general, marketplace object can be added automatically via the Marketplace API. However, the system also allows creating a new marketplace manually by using a wizard.

Click the **Create Marketplace** button from the *Marketplaces* tab to launch the aforementioned wizard.




Thereafter, the wizard helps to define your marketplace, select associated countries, choose currencies, locales, map required hubs, select price attributes and so on. Once your marketplace is created, it will be available within the **Directory** tab.

In case step-by-step instructions on your marketplace creation are required, please refer to the Distributor Tutorial documentation.

Marketplace Details

Click on your marketplace name from the provided list to access the **Marketplace Details** screen:

It is also possible to remove your marketplace by clicking on the (⋮) icon and selecting the *Delete* option. Note, however, that the system doesn't allow deleting marketplaces with assigned active agreements.
